Harrell of the county and state aforesaid of the other part with in itself that I Ransom Day Sr. for and in consideration of the sum of four hundred dollars to him in hand paid the receipt where of is hereby acknowledged both and by their presence doth grant bargain and sell unto the said Ezekial P. Harrell a certain tract or parcel of land lying and being in the county and state aforesaid on the brand of Sycamore creek and bounded as follows Beginning on Thomas H. Rice witness to said conditional line and it is now Especially agreed upon that the said Ransom Day Sr. doth hereby relinquish to the said John Loveless all his rights his interest and claim that he has to any land lying on the west side of said conditional line as an indefensible inheritance and the said John Loveless doth hereby relinquish to the said Ezekial P. Harrell all the rights his interest and claim that he has to any land lying on the east side of said conditional line as an indefensible inheritance then from the end of said conditional line down the hollow to a spanish oak hence Eastwardly to a pine and spanish oak then south westwardly eighty six poles to a line of a \_\_\_\_\_ to Thomas Clifford's for 650 acres hence with said line north to a white oak and black walnut corner of said hence with Thomas H.
